## Privacy Policy Pol-HSEQ-009

We will never provide your information to a third party for marketing or promotional purposes and we will never sell your information.

- 1 **Open and transparent management of personal information** Natural Area will manage personal information in an open and transparent way.
- 2 **Anonymity and pseudonymity** Individuals have the option of not identifying themselves, or of using a pseudonym, when dealing with Natural Area in relation to a particular matter.

- 5 **Notification of the collection of personal information** Natural Area will ensure individuals are informed if we intend on collecting personal information.
- 6 **Use or disclosure of personal information** Natural Area will not disclose personal information without prior consent.
- 7 **Direct marketing** Natural Area will not use or disclose personal information for the purpose of direct marketing.
- 8 **Cross-border disclosure of personal information** Natural Area is not likely to disclose your personal information to anyone overseas, in the case that this does occur and Natural Area discloses personal information about an individual to a person who is not in Australia or an external Territory, we will take such steps as are reasonable in the circumstances to ensure that this recipient does not breach the Australian Privacy Principles.
- Adoption, use or disclosure of government related identifiers Natural Area will not adopt a government related identifier of an individual as our own identifier of the individual. A government related identifier is a number, letter or symbol, or a combination of any or all of those things, that has been assigned by certain government entities and is used to identify the individual or to verify the identity of the individual.
- 10 **Quality of personal information** Natural Area will take such steps (if any) as are reasonable in the circumstances to ensure that the personal information that we collect is accurate, up-to-date and complete.
- 11 **Security of personal information** Where Natural Area holds personal information, we will take reasonable steps to protect the information from misuse, interference and loss; and from unauthorised access, modification or disclosure.
- 12 Access to personal information Where Natural Area holds your personal information, on request by the individual we will give the individual access to the information.
- 13 **Correction of personal information** If personal information held by Natural Area is inaccurate, out of date, incomplete, irrelevant or misleading, we will take steps to correct the information.
